base of organizing efforts and provide a meeting place for members and training efforts. This is part of the commitment the ARCC has to being involved in the

communities where our members live. The Mat-Su office is also hosting Quantum Health's cooking classes for cancer patients and their families on Tuesday mornings.

By now you should have seen the ARCC commercials promoting our skilled hands to contractors and encouraging non-union workers to seek us out. The commercials primarily air on FOX, CBS, and cable stations. As soon as possible, we hope to have the commercials on the website at www.ubcalaska.org. The website also hosts contact information for all Locals and training centers.

A Millwright Training Center through the Northern Training Center has been opened on the Kenai Peninsula off of Kalifornsky Beach Road near the college in Soldotna. This Training Center hosts a Solar Saturn gas turbine, Elliot stream turbine, and a recently donated Flowserve Acrylic Pump and Seal Demonstrator from the UBC. In addition to the regular training curriculum, the instructors are developing recip compression training with Dresser Rand FSS and a dry gas seal with Pro-Seal.

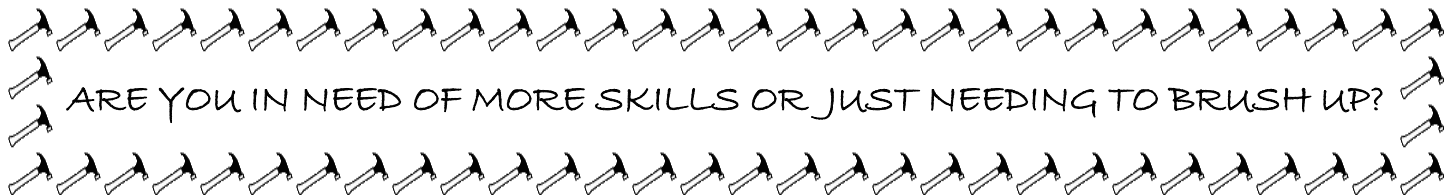

The Statewide election is November 7, 2006. There are many good candidates that support the working men and women of Alaska. These are the people that support you, that believe in a fair day's pay for a fair day's work. The ARCC is proud to announce their support of the following candidates:

STATEWIDE

US HOUSE DON YOUNG (R)

What can we say? He keeps delivering projects for Alaska and is a strong supporter of Davis Bacon and workers' rights.

GOVERNOR KNOWLES/BERKOWITZ (D)

Tony Knowles and Ethan Berkowitz have been long supporters of workers rights, livable wages and capital projects. If a Gas Line is to be built, Knowles probably stands the best chance of getting an agreement. Although the other candidates have compelling reasons to support them, the ARCC sees the experience and longtime carpenter supporter to have the edge. This year has many candidates that have worked in Labor including Bill Wielechowski (State employee), Harry Crawford (Ironworker), Bob Buch (Plumber), Valerie Baffone (Laborers and Nurses Association), Chris Tuck (Electrician), Joe Thomas (Laborer), and David Guttenberg (Laborer). AFL/CIO HONORS ARCC CARPENTERS DWAYNE CARLSON AND DAN HOFFMAN RECEIVE AWARDS

The Alaska AFL/CIO bestowed one of their highest honors to Dwayne Carlson and Dan Hoffman.

Dwayne Carlson, former Carpenters Local 1281 member and longtime political activist, was selected to receive the Alaska AFL/CIO's 2006 Robert A. McFarland Award in recognition of a lifetime of service to the labor movement in Alaska. Dwayne stated that he was humbled to receive such an honor and is touched that people still remember him.

Dan Hoffman, former Training Coordinator for the Fairbanks Training Center, was also a recipient of the Alaska AFL/CIO's 2006 Robert A. McFarland Award in recognition of a lifetime of service to the labor movement in Alaska. Dan is a 44 year member of the UBC, serving 38 of those years in Alaska. He was the Fairbanks Training Coordinator for twenty years and is still an active member of Local 1243.
